#### COMMANDERS REPORT

Once again it is my priviledge to present a report as your Department Commander. I have been honored to represent the fine Department of Michigan in this capacity for the past two years. The support and friendship of the Brothers has been greatly appreciated.

Several long-term problems were resolved early in this year as the problem with the Rowley Camp #18 came to a conclusion. We were also pleased that the complaint filed by Norman Rowley with the Michigan Department of Civil Rights was dismissed because no basis for the complaint was found in the investigation.

With this business behind us, we were off to the National Encampment in Connecticut in August. We returned home with more duties and responsibilities than when we left. The job of being National Secretary has made this agreey challenging year.

In October we were off to Des Moines, Iowa for the annual meeting of the Central Region Association. This well attended event was an outstanding weekend and a great opportunity to get together with key folks from the Department in the Midwest.

The Department, in cooperation with the Sons of the Revolution in the State of Michigan sponsored the annual observance of the birthdays of George Washington and Abraham Lincoln. This years program was presented by David D. Finney of Howell. He provided an illustrated talk on the final days of Lincoln and his death.

The Department was represented in Springfield, Illinois on 14 April for the Lincoln Tomb Ceremonies marking the 125th anniversary of the death of President Lincoln. It was great to note that all of the Department of the Central Region were represented.

Memorial Day weekend found the Department Commander at the Daughters ceremony at the Sunfield Cemetery on Sunday and at the Allegan program and parade on Monday. Special services were again conducted at the gravesite of General Benjamin Pritchard. Note was made that this year marks the 125th anniversary of the capture of Confederate President Jefferson Davis by the unit commanded by General Pritchard. It was gratifying to note that the SUVCW was moved to the beginning of the program this year and that the veterans organizations of the following wars were presented in the historic sequence of their action.

It is gratifying to note that more Camps are conducting services on May 30 in their communities. Only by constantly emphasizing that Memorial Day (Decoration Day) is a Civil War observance and should be returned to it's historic date can we accomplish the task of restoring the date established by the Grand Army of the Republic.

The Department has continued to grow during the past year, although not at the rate of years previous. We have been able to visit each of the Camps of the Department this year, with the

exception of the George Howe Camp in Port Huron. All of the Camps, except Howe, have initiated new members during this past year.

A real highlight of the past year, which almost slipped my mind, was Remembrance Day in Gettysburg in November. It has been some time since Michigan has been represented at this event, and a few folks were surprided to see us there.

There were several things I had hoped to get done this year, but did not, and several things that I should have done but I forgot to do them. In spite of this, I think the Department had a pretty good year in general terms.

As I leave office, there are several things that I would like to recommend for your consideration;

- 1. Efforts must continue and be intensified on the effort to reactivate the Auxiliary in Michigan. We need the boost the an effective Auxiliary can give to our efforts. This must be the year we get the job done!
- 2. We must increase our efforts at recruiting new members and take advantage of situations similar to the one we have at the Jackson event each year. Two obvious choices would be at Crossroads Village and at Fort Wayne. There are others.
- 3. We need to take advantage of the opportunities afforded by events such as the Grand Haven Coast Guard parade and those projected by the Greater Michigan Foundation for the next ten years. We must take every opportunity to show our new flag.
- 4. We must increase our efforts to complete the organization of the several new Camps we have been working on. We need to assign members to each who will follow-up and complete the job.
- 5. Finally we must make a greater effort to have functioning committees and involve more people in the operation of the Department. We have moved forward on the efforts of too few people in the past, and must change this pattern if we are to complete the projects necessary to meet the objects of our Order.

It has been a great pleasure to work with all who have been helping to move the Department forward. Your efforts and support provide the glue that keeps us together. I am sure that my successor will enjoy the same as he assumes office.

Report of the Michigan Department By-Laws Committee.

The By-Laws committee was requested by the 100th encampment to define the role of the Department Chief of Staff.

After consulting numerous references, including the Constitution, Rules and Regulations of 1889, 1920, 1939, 1956, and 1982, and the Department By-laws of 1940, the following information was obtained.

In only one istance is the Chief of Staff mentioned in any of the sources mentioned. That is in the Department By-Laws of 1940. In Artical 14, Section 1, titled "Reserves", referring to the Sons of Veterans Reserves, Quote:

"There shall be military units within the Department known as S.V.R. and the Department Commander shall appoint a member of the Order, preferably one familiar with military affairs, as Chief of Staff, and if the appointee be a Department Commander, his rank shall be Colonel, if not a Past Department Commander his rank shall be Lieutenant Colonel."

It is therefore the recommendation of the By-Laws committee that either Artical 14, Section 1, of 1940 be re-adopted into the current by-laws, or leave the defenition of the role up to the discression of the individual sitting Commanders.

#### Report of the Historian

Department of Michigan Sons of Union Veterans of the Civil War

The Department of Michigan, Sons of Union Veterans of the Civil War, was active at the national level as well as in the State and in the local camps this past year. At the 108th National Encampment at Stamford, Connecticut, Brother James Lyons was elected National Secretary and was chosen to chair the National Encampment Site Committee. Brother Gary Gibson was appointed to be Chaplain. Brother Keith Harrison was selected as National History Book Coordinator and named to serve with the Coordinator of SUVCW 125th Anniversary Events. The Department also was well represented at other events such as the SUVCW Central Region Association meeting in Des Moines, Iowa, and the 34th Annual Lincoln Tomb Ceremony at Springfield, Illinois.

The Department bylaws provide for the office of Historian but do not assign specific duties to it. Such appointed officers are charged to "...perform duties as specified by the C & R, Ritual, Department By-Laws, and/or the orders of the Department Commander." A variety of activities which could be conducted through this office were suggested in the Historian's annual report and were considered at the Department Encampment last year.

In light of that discussion, the following suggestions are made for consideration by the Department Commander and by any others as may be appropriate.

- A. A committee be appointed to serve under the chairmanship of the Department Historian.
- B. The committee consist of one member from each Camp, as appointed by the Department Commander, with suggestions from the Camp Commanders, providing broad participation across the entire Department.
- C. The committee be given specific charges. Some examples are: collect, organize and issue information about the Grand Army of the Republic here in Michigan; gather, assemble, and issue biographical information about the Union veterans from whom the Department members are descended; and collect, organize, and preserve historical papers and other materials of the Department of Michigan, Sons of Union Veterans of the Civil War.

Specific charges to this office, to this committee, and to the other committees would help set a direction for the Department.
