- 2) Amendment to National Regulations to legally adopt the name, badge, emblem, seal and insignia of the Grand Army of the Republic. Motion to accept the change by Brother Harrison, seconded by Brother Gregory, motion passed.
- 3) Crapo Camp by-laws change to suspend members 6 months in arrears of dues payment and terminate after 1 year. Brother McKinch moved to accept the change and pass on to the National Encampment, seconded by Brother Gregory.
- 4) Proposed amendments to the National Regulations to include a History Committee and a Committee on Americanization and Education. Motion by Brother Harrison, seconded by Brother Gregory; motion passed.

- Max Reske's proposals.
  - a) Grant permission for officers and enlisted men in the Army & Navy of the US to wear the badges adopted from previous military engagements. We aren't Civil War Veterans and thus shouldn't be wearing those medals. If reproduced, collectors couldn't tell the new from the original.
  - b) Urge the U S Government to reproduce the Civil War medal using the original dye and make it available for purchase by descendants of Civil War Veterans. Doesn't distinguish between North & South. Send back to Max.

- 2) Nomination for Brother Harrison for the position of Commander-in-Chief moved by the committee, seconded by Brother Streeter, motion unanimously passed.
- 3) Nomination of Alan Loomis as Junior Vice Commander-in-Chief moved by the committee, seconded by Brother Lyons, motion passed unanimously.
- 4) Nomination for Dave Wallace to the position of National Secretary was moved by the committee, seconded by Brother Lamphere Jr, motion passed unanimously.

Brother Lyons moved the report be referred to the By-Laws Committee for review and be brought back to the next Department Encampment, seconded by Brother Lentz. Vote was too close to call verbally, so a show of hands was required. The vote was a tie, vote did not carry.

A vote on the original motion was also too close to call verbally, so a show of hands again was required. Motion passed, 19 yes, 15 no.

#### **New Business:**

- 1) Sold 11 LOGAN street signs at \$2.00 each (\$36)
- 2) Jack Patch distributed invitations to the members to attend a rededication of the West Concord-West Brick Cemetery located West of Concord, Michigan and dinner on July 9 put on by the Austin Blair Camp. Filed with the Department Secretary.
- 3) Jack Patch also presented a check to the Department for the purposes of purchasing a tent to use at events for the purpose recruiting new members. Austin Blair received their charter on June 11, 1914 and today is exactly 80 years later. The check presented by Austin Blair was in the amount of \$80.00 (\$1 for each year). Jack also challenged other Camps to contribute \$1.00 for each member toward the purchase of a recruiting tent.
- 4) Request from Department Membership at Large Commander, Terry McKinch to include a ritual in the packet of information sent to new members. He has control of the Camp funds so he has control of what items to spend the Camp funds for the good of the membership.
- 5) Suggestion a Son's meeting be organized for Son's from all Departments attending the Jackson Civil War Muster.
