- C. By-Laws Committee. Written report submitted. Proposed changes to the Department By-Laws were submitted to Camps in April as required by the By-Laws. The primary change is to split the position of Secretary-Treasurer into two separate positions. A change in the wording in the SVR area of the By-Laws was requested by the National Councelor to comply with the Constitution and Regulations. The committee also recommends additions to the Operating Guidelines for the Department's fiscal year end, accounting periods for the Department and National Encampments and the encouragement of the "Juniors" program. The Committee also recommends the Job Descriptions for Camp and Department Officers, as approved by the 1994 National Encampment, be adopted as part of the Department Operating Guidelines.
- D. Central Region Meeting. Verbal report given by Brother Harrison. The meeting was held in Illinois last October. Attendance was low. Next meeting location is unknown at this time.
- E. Michigan Department Mid-Winter meeting & Washington/Lincoln dinner. Verbal report given by Brother Brennan. Max Rickse was the guest speaker for the evening.

- 5. Commanders Group. Brother Harrison gave a verbal report on the representation of the Order in the Commanders Group.
- 6. It was mentioned Thayne LaBanta stayed home this year because his wife is ill.
- 7. Peter Dixon's National Council term is over this year and he may not run. Brother Pahl moved J Douglas Park be endorsed by the Department for that position. Seconded by Brother Harrison. Sent to the Resolutions Committee.
- 8. The Commander-in-Chief, Keith Harrison, presented a verbal report on how the National Organization is changing. He indicated how many National Officers are using electronic mail, how many functions are being accomplished using computers, how the Department by-laws are being reviewed and changed to not conflict with the Constitution and Regulations of the National Organization, that we now have job descriptions for positions and how the National Organization is filling positions with people who want to perform the duties of their position.
- 9. Brother Lyons submitted a report on the accomplishments of the Graves Registration Committee's activities for the previous year. The report includes a background of the project, project scope, secondary projects, recording the results, committee structure, resources, some helpful hints and conclusion.

- 10. Brother Lyons submitted a written report on the efforts he accomplished during the last year on designating M-99 as General John A Logan Memorial Highway and included recommendations, pictures and a list of other highways designated as memorial highways.

- b) Endorsed the creation a position of Scout Liaison. Referred to the Resolutions Committee.

1. Brother Park suggested we have a discussion and have a committee in place to coordinate a joint Son's meeting with members of other Departments who are in attendance at the Jackson, Michigan Civil War Muster the last weekend in August.

Brother Wallace, Harrison, McKinch and other members of the Department of Michigan attended the Annual National Organization of Daughters of the Union 1861-1865 on May 20, 1995 at Wally's West in Flint, Michigan. The National Colors, Department Colors and Governor Crapo Camp Colors were displayed by the Department Color Guard.

Committee Reports:

Bylaws Committee: Brother Wallace, chair.

- 1) Proposed By-Law changes were submitted to Camps 60 days prior to the Department Encampment.
 - a) The changes were necessary to divide the office of Secretary/Treasurer into separate Secretary and Treasurer positions. The wording was such that one person could fill both positions or each position could be filled by a different person.
 - b) Spelling errors from previous revisions were also included.
 - c) The fiscal year for the Department was set at June 1 through May 31.

Brother Wallace moved the changes be adopted. Seconded by Brother Gibson. Motion passed.

Resolutions Committee: Brother Pahl, Chair.

- 1) Henry E Plant Camp endorsed urging the US Government to reproduce the Civil War medal using its original die; that the medal be made available for purchase by descendants of Civil War veterans; that no more than \$10 be charged for shipping and handling and profit over and above the cost of producing the medal and that the profit be used to decrease the deficit; the medal would be available only through a military related society originally composed of men and women who served in the armed forces, North or South, or who are members by inheritance of said societies. The Committee moved to accept the resolution, seconded by Brother Harrison. Motion passed 16 to 8.
- 2) Henry E plant Camp endorsed petitioning Congress and the Secretary of Defense to allow, on occasion of ceremony, all present members of the United States Armed forces to wear their American military hereditary society badges and medals for which they are qualified. The committee moved to accept the resolution. Seconded by Brother Dave Wallace. Motion passed.

- 3) Gilluly-Kingsley Camp resolved to create a position of Scout Liaison whose duties will include working with Boy Scouts of America Councils in recognition of Eagle Scouts and to develop a program related to the Genealogy Merit Badge and selected other badges leading to some form of award. Committee moved to accept. Seconded by Brother Hodges. Motion passed.
- 4) The Committee endorsed these Brothers for National Office:

David R Medert for Commander in Chief Alan R Loomis for Senior-Vice Commander-in-Chief Richard D Orr for Junior-Vice Commander-in-Chief J Douglas Park for National Council David D Wallace for National Secretary

Seconded by Brother Harrison. Motion passed.

Recessed for Lunch and returned to finish business.

5) Alexander French Camp proposed to add the Camp name to the Citizens Flag Alliance Petition and urges the National Organization to encourage Camps to sign the petition.

The petition supports adopting a constitutional amendment to prohibit physical desecration of the United States Flag.

A good discussion showed there is a strong feeling within our group to support the concept, and also a strong feeling that we must be careful in the definition of what constitutes desecration. Although the Department endorses the principle of the petition, there is a lack of specific language that would allow us to support the petition at this point.

Brother Harrison moved the Department forward the petition to the National Organization indicating the Department endorses the proper use of the United States Flag. Seconded by Brother Dave Wallace. Motion passed.

Officer Report Committee: Brother Gibson, chair.

Committee reports all officers reports presented to the committee are in order.

Legislative Affairs Committee:

No report.

Council Report on the Budget:

The report on the activities of the Council during the previous year was presented by Brother Hodges. The budget for the coming year was reviewed by the Council prior to the Department Encampment. Motion to accept the Council report made by Brother Harrison. Seconded by Brother Neal. Motion passed.

The Budget for 1995-1996 was presented. Discussion and figures presented by the Department Secretary/Treasurer. The Council also recommends no increase in the Department per-capita taxes. Brother Hodges moved the budget and no increase in per-capita taxes be accepted by the Encampment. Seconded by Brother Gibson. Motion passed.

New Business:

1) Brother Harrison moved the Department send \$25 to the Patriotic Instructor Fund and \$25 to the Senior-Vice Commander-in-Chief fund, seconded by Brother Dave Wallace. Motion passed.

- 3) Brother McKinch invited all Brothers to attend the Crossroads Village muster June 25. A Son's meeting will be in the church at 5:00 P.M. followed by a picnic. The meat is furnished by the Governor Crapo Camp. Bring a dish to pass. If you plan on attending, give your name to Brother McKinch before you leave and you can get in the village free.
- 4) Brother Adams announced a picnic will also be held at the Charlton Park muster. A Son's meeting at 4:00 P.M. at the church with the picnic to follow immediately. Bring your own table service and a dish to pass.
- 5) Brother Park suggested the Department continue trying to designate Highway M 99 from its beginning in Lansing to the Ohio border (See the report presented by Brother Lyons). Brother Richard Williams recommended the recommendations presented in Brother Lyons report be adopted. Seconded by Brother Park. Motion passed.

Treasurer's Report:

Income and expenses from the previous year were presented by the Department Secretary/Treasurer. Because of the changes in the By-Laws the fiscal year was extended from March 31 to May 31. Even with the additional two months in the fiscal year, income and expenses were within the proposed budget from last year. Balance as of May 31, 1995 is \$5,040.29.

Of that money we are holding \$600 for a highway marker for the Iron Brigade; \$58.25 for the Russell A Alger Camp at Large; \$80.00 for the Michigan Department SVR; and \$505.77 for the Russell A Alger headstone account

Brother Harrison moved the treasurer's report be accepted. Seconded by Brother Dave Wallace. Motion passed.

Good of the Order:

- 1) Abraham Lincoln Certificates of appreciation were presented at the Encampment because not all recipients could attend the dinner following the Encampment. Recipients this year are: John Mann, J Douglas Park and Richard Williams.
- 2) Publications Report was discussed. Encouragement for all Brothers to write articles for the Messenger was presented by Commander Brennan and Brother Richard Williams. This is our means of communications and not only are the Department Officers and Camps requested to submit articles each quarter, but individual members are also encouraged to use this as a means to get information to other Brothers.
- 3) A new Camp, George W Anderson Camp 58, will have its first meeting Monday evening, July 17 at 7:00 P.M. at the VFW hall on M 127 just East of DeWitt.
- 4) Brother Wallace recommend the Michigan Department extend a formal greeting to the newly formed Department of the Southwest by way of a letter from the Department Secretary..
- 5) We discussed a letter from Brother Dave Wallace on redeeming GAR cemetery lots in Whitehall. Brother Calder moved the Department purchase the 7 lots at the stated price of \$15 each for a total of \$105.00. Brother Calder moved we purchase the lots. Seconded by Brother Graves. Motion passed.
