Council:

Report from the council was given by Keith Harrison. The Council recommends the Camp-at-Large membership dues be increased from \$25 to \$26 to cover the needed minimum due to pay per-capita. James Lyons moved the recommendation be accepted by the encampment. Seconded by Rick Danes. The motion passed.

Officer Reports:

The Committee on Officer Reports was presented by Dave Wallace. The committee recommends the adoption of the minutes of the 113th annual encampment with the following corrections.

- 1) Page 4, PC-in-C Harrison reported that the GAR flag is missing from the display of veterans organization flags in the State Capitol. He indicated that the VFW Department of Michigan will assist by raising funds to help replace it.
- 2) Page 5, correct the spelling of Camp 20's secretary from Borker to Baker.

Bill McAfee move the minutes be accepted as corrected. Seconded by Gary Gibson. During the discussion James Lyons objected that the minutes of last years encampment not be approved until the member of last years encampment have had a chance to review the minutes. Keith Harrison suggested the minutes be tabled until next years encampment and that the minutes from the 2002 Department Encampment be distributed to the attendees of the 2002 Department Encampment for their review. Motion made by Rick Danes to table the 2002 Department Encampment minutes until next years encampment. Seconded by Neal Breaugh. Motion passed.

By-laws:

By-laws Committee Report was given by Keith Harrison. See attached by-law changes.

We got into a discussion on the Department Encampment's inability to make any changes to any wording of the by-law changes at the Department Encampment because of the 60 day limit imposed in the by-laws and a ruling by the National Counselor at last year's Department Encampment. A lengthy discussion followed as to whether the change was at all necessary. We determined the change was necessary.

- 1) Article XIV, Amendments, Section 2. This proposal allows the encampment to modify wording of previously distributed proposals to amend the by-laws. The encampment by-laws committee recommends the proposal be accepted. A discussion followed. In the end, the by-law change was determined necessary. Neal Breaugh moved the by-law change be adopted. Seconded by Robert Grove. Motion passed. The Commander-in-Chief, Bob Grim, was asked if he'd approve that change to the Department's by-laws immediately. He did.
- 2) Article III, Officers and their duties, Section 2. Change the Civil War Memorials Officer title to match the title changed at the 2002 National Encampment. We've subsequently learned that the title change should not have been made at national level and the committee recommended the change be rejected.

Motion made by James Lyons to reject the proposed change, seconded by Robert Grove. Motion passed.

Date: 04/05/2003

- Article III, Section 5. By-laws committee asked this section be removed because a committee of the Michigan Allied orders handles the selection of the site. The encampment by-laws committee gave no recommendation. A discussion followed indicating that it was important to keep the Department Commander responsible for assuring that the Department Encampment takes place at the designated time and should not be relinquished to a committee even though the actual process of making arrangements may be designated by the committee, the ultimate responsibility still rests with the Department Commander and needs to be so stated. James Lyons moved the change be rejected. Seconded by Howard Streeter. Motion passed.
- 4) Article III, Section 6. By-laws committee asked the section be renumbered to section 5 because of its recommendation to eliminate section 5. Removal of section 5 did not pass. Bill McAfee moved and Dave Wallace seconded that the change be rejected. Motion passed.
- Article III, add new Section 6. This new section would require Department Officers to turn over all materials when relieved of duty to the Department Historian. The encampment by-laws committee gave no recommendation. Rick Danes supported the addition and Richard Veit supported. A discussion followed bringing up many good points on preserving the materials, cost of copying, reimbursement, storage, and access to the data. Jim Lyons moved and Gary Gibson seconded to table the proposal until next year encampment. The proposal is to be sent to the By-laws Committee to set up procedures for implementation of the proposal and report to the next Department Encampment.
- Article III, Section 7. Delete the election of delegates to the National Encampment since it is covered in Article XX. The encampment by-laws committee recommended to accept. A discussion pointed out that although the material presented in both was similar, that Article III, Section 7 is the appropriate place for this. Article XX, Section 5 should be deleted to remove the redundancy. Dave Wallace moved and Gary Gibson seconded that the section not be deleted. Motion passed.
- 7) Article IV, Authorized expenditures. The proposal is to delete Sections 1-5 and replace it with a general statement that officers will be reimbursed for expenditures approved by the council after review of the budget proposed by the Treasurer. Jim Lyons moved and Dave Wallace seconded to support the change. Motion passed.
- Article VII, Reports, Section 2. Put a timetable on getting the encampment minutes to Department Officers 60 days after the encampment. Jim Lyons proposed an amendment to also include Camp Commanders, Camp Secretaries and all attendees of the Department Encampment. Gary Gibson moved and Richard Veit seconded that the amendment be accepted. Motion passed. Dave Wallace moved and Gary Gibson seconded the amended proposal be accepted. Motion passed.
- 9) Article IX, Committees, Section 1. The proposal was to change the Civil War Memorials committee to Memorial and Monuments. An earlier change negates the necessity to do this. A discussion followed and it was determined since we can modify by-law changes at the encampment that we would modify this proposal to take out the Weekend of Remembrance Committee and add the Ceremonies and Rituals Committee. Neal Breaugh moved and Rick Green seconded the modified proposal be accepted. Motion passed.
- 10) Article IX, Committees, Section 4. Modified to send modified by-laws approved by the Commander-in-Chief to the Department Signals Officer to post on the Department Website. Dave Wallace made an amendment to the proposal to also include that the proposal comply with the National Organizations' Electronic and Communication Policy for storage on the website and that Camp Commanders and Camp Secretaries also receive a copy of the approved by-laws. The amendment was seconded by Jim Lyons. The amended proposal passed.
- 11) Article IX, Committees, Section 8. Change the name of the committee from Civil War Memorials to Memorials and Monument. An earlier motion rejected the name change. The encampment by-laws

committee recommended to reject the change. Bill McAfee moved and Rick Danes seconded that the change be rejected. Motion passed.

- Article IX, Committees, Section 11. Delete the reference to the Weekend of Remembrance Committee since it no longer exists. The encampment by-laws committee recommended to accept the proposal. Moved by Dave Wallace and seconded by Jim Lyons to accept the proposal. Motion passed.

- 4) Item 3. Add the language of "The number of Department representatives" to the beginning of the item. Moved by Jim Lyons and seconded by Dave Wallace to accept the change. Motion passed.
- 5) Item 4. Delete the item referring to Camps having juniors since the bylaws already handle it. Motion by Jim Lyons and seconded by Dave Wallace to reject the deletion. Motion passed.

Treasurer's Report:

Keith Harrison, Council Chair, moved that the Treasurer's budget as presented to the council and discussed earlier in the encampment, be approved. Seconded by Howard Streeter, Council member. Motion passed.

Committee Reports:

Gary Gibson reported no recommendations were in any officer report. Found the reports in good order. Jim Lyons move the Committee Report be adopted, seconded by Dave Wallace. Motion passed.

Jim Lyons objected not having a chance to review the minutes from last year but will move to take the minutes off the table. Dave Wallace seconded. Motion passed. (Under Officer Reports, the approval of the 2002 Department Encampment minutes were tabled until next year. This motion removed that motion.)

Jim Lyons moved the minutes for the 2002 Encampment be approved as amended earlier in the Encampment. Seconded by John McFeters. Motion passed.

Election of Delegates to the National Encampment:

Keith Harrison moved that the delegates to the National Encampment be determined by reverse alphabetical order of the registered delegates at the Department Encampment less any members with outstanding credentials to the National Encampment up to our maximum number of delegates allowed and all others on the Encampment list be alternate delegates. Seconded by Jim Lyons. Motion passed.

Bruce Butgereit II read the names for the elected officers of the Department. No nominations were made from the floor. Jim Lyons moved the nominations be closed and the Secretary be moved to cast a unanimous ballot for the slate presented. Seconded by the encampment. Motion passed.

May 17 has a Hayden rededication in VanBuren County.

April 13 there is a rededication in Adrian.

June 28 there will be a 135 anniversary of the G.A.R. in Jonesville. See the Messenger for more information.

July 25 through 27 there will be a National Civil War Band festival in Campbellsville, Kentucky. Eleven Civil War bands are participating.

Dear Commander,

There are several items that I wish to briefly report to the Department at this Mid-Winter Conference:

- The work of the By-Laws Committee
- The response to Messenger reports
- The suggestion of several future projects

The Department By-Laws Committee consists of Rick Greene, Dick Williams, Bruce Butgereit II, Philip Parks and Exofficio, Commander Bruce Butgereit. The Proposed By-Laws that all the Camps should now have for their review were the inspiration of our Commander gleaned from his extensive experience as the Chair of the previous year's By-Laws Committee. It is expected that you give them your close attention and instruct your Delegates to present your Camp's position on these amendments, alterations and additions at the Department's Annual Encampment. The By-Laws now require a two-thirds vote of the Brothers present and entitled to vote at the Annual Encampment to approve these proposed changes.

The "Messenger" published three communications since I was elected DSVC. The first emphasized the job description and our need to communicate outside and inside the Department. A request was made for each CSVC to communicate with me about their Camp and themselves. One SVC responded. The second note emphasized how our participation in community activities, such as a Gun and Knife Show, Civil War Living History Encampment and Michigan Department of History event, Iron Ore and the Civil War, which are great for recruitment and keeping the SUVCW in the public eye. At least 17 newspapers in the UP responded with coverage of these events. The third message proposed some specific examples on how Camps can respond to the challenge to rise above the background noise. Being on the lookout for opportunities is essential but like so many other things in life it must begin at home, our Camp, our town and our county. Another personal example, several years ago Camp 266 was planning to have a rededication service for the placing of our first grave marker for Sergeant Orla W. Doolittle of the Charles H. Towne, GAR Post No. 8, of Ishpeming. I spent many hours of communication and planning with a representative of WLUCTV6. At the Ishpeming Cemetery that Saturday we gathered, finally a young lady with a camera came to record the ceremony. No names asked for nor questions about the service which was to be the

first of a continuing series on the Civil War veterans in the Upper Peninsula. I got a call when I got back to Hancock that this <u>series</u> was now going to have 30 seconds on the 11:00 pm News this very Saturday night! The lesson is try to make the media think it was their idea. But we can start small with a Camp newsletter even if it only contains the minutes of the last Camp meeting. The Christmas letter that I sent out to all Senior Vice Commanders was also intended to encourage each Camp to start small with good Camp communication before trying to launch out into the deep. That letter got the greatest number of Newsletters sent to me, 4! I just know there must be at least 22 more out there somewhere. Our goal can be to have every Camp produce a Newsletter.

There are several topics and issues that occur to me that may find a voice of sympathy or a united response of the SUVCW, Department of Michigan.

- 3. The month of April to be devoted to the memory and accomplishments of Lt. General Ulysses S. Grant. Born April 27, 1822 and brought us Victory April 9, 1865. He lived in Detroit in 1849 and owned property in our fair State.
- 4. Anti-war demonstrations should be answered both Nationally and Departmentally, giving support to the C-in-C by the SUVCW.
- 5. The Boy Scouts are under attack again for their stand against homosexual leaders in their ranks. The SUVCW can defend as well as support the Boy Scout movement.
- 6. Homeland Security Department is in need of reliable men to become the backbone of a working Civil Defense system, what better source than the ranks of the SUVCW.

Let these be considered for the good of the Order. Subject: Annual Report

It is a pleasure to once again report on the progress of this project. Activity was slowed due to the unavailability of several key committee members for substantial periods of time during the past year. We have also experienced a drop-off of reports from members and Camps concerning newly found Post records.

There has been some progress on several fronts, however. A retired Library Director has contacted me concerning a Post minute book in her possession. She is going to copy the book and will be sending the first forty pages in the next few days. She also thinks she may be able to locate another minute book from the same Post. This contact came through our page on the Department web site.

We have also turned up a lead on the possible location of a Post flag. It has been several years since this flag was last seen, but we are checking with several people regarding its location. More will follow on this.

Communication has been established with the archivist at the Clarke Historical Library at Central Michigan University. They have a number of G.A.R. Post materials and related manuscript files in their collection.

We continue to locate former G.A.R. Halls in various communities. The Hall in Vermontville is now the home of the local American Legion Post. We have located a building in Belding, fitting the location and general configuration of a Hall. More research will need to be done to verify this building. A search is under way to identify and locate a Hall pictured in an old photograph given to the Daughters of Tent 30. It is believed that this Hall was in Ionia County.

During the past year, we have made four presentations to Genealogical or Historical Societies.

Between 70 and 80 requests for research assistance were handled during the year.

Work on the G.A.R. Membership data base project continues. We are working on Post 43 and now have nearly 13,000 entries. There are also 2321 annual officer rosters included as a separate table. With the assistance of Dick Williams we have now developed a

We have now begun a project to provide "Post Notes" giving a brief history of the Post, information on the person for whom the Post was named, where the Post met and other things of interest regarding the membership. A brief history of the Department of Michigan, G.A.R., as presented on the Department and National web page listings of G.A.R. Posts, serves as the introduction to this companion piece to the Membership database.

During the past year in a different, but related project, we have completed (for the second time) the transcription of the National Card File Index of Camps into a database. This is a "one of a kind" record. We now have the ability to extract information, in several formats, and place this important record in several locations as a backup for the original cards. There are 3704 Camps recorded.

Work has begun to transcribe the information contained in the ledgers recording approved applications for Camp Charters. This material includes the date of publication in General Orders. There are two volumes dating from 1905 to the late 1940's. By 1950 this information is recorded in the Membership accounting ledger and is in a different format. Eventually this material can be cross-referenced with the card file information to provide a full picture of the Camp history of the Order. Reporting in recent years has been less specific, but will be included as presented.

This work continues to provide surprises and many great satisfactions as new things are discovered. New areas of research follow these discoveries providing many challenges to put all the pieces together. I am thankful for the opportunity to work on these important projects and hope to be able to continue until their completion.

Commander Butgereit,

Please accept the attached as a final report for the year 2002-2003 of activities from the Department of Michigan Graves Registration Committee.

The achievements of Committee during the past year although significant, did not meet the stated goals from the 2002 Report. We were not able to recover all records held in the Camps, and although we encouraged the Camps, were not able to achieve a GRO for each Camp, nor an active program throughout the Department.

The significance of our work since February 2002 can be recognized with an additional 11,326 records entered into the Department database, and 11,377 records sent to the National Chairman. Approximately 2,000 records currently await input to both.

Quarterly committee meetings were held, and were attended by a core of approximately 50% of the Camps. Like the 2001-2002 year, these meetings achieved meaningful dialog that is useful to the Camp GROs and allow them a forum to express ideas, concerns, and allowed them to spend time learning more about the resources available to them. We have created a living list of abbreviations, sources, and resources updated for each meeting, and each attending Camp receives an updated cd containing the most current Department db for their use. The Graves Officer Handbook was updated and distributed.

I mentioned at the last 2 Department Encampments that we have found the lack of participation from some camps reflective of the overall attitude of society today. Although that fact has not changed, certain proactive members have overcome the hurdle by working outside their normal areas and by soliciting participation by non-Members.

Under your leadership and support, the Department of Michigan Graves Registration Program has been selected by National Officers to provide guidance to the Department of Tennessee they structure their program.

I appreciate the opportunity that I have been given, and hope that you, as well as future Commanders allow me to remain Chairman of this Committee with the goal of completing the task at hand. I remain,

2003 GRAVES REGISTRATION COMMITTEE ANNUAL REPORT

BACKGROUND

In spite of the Nation's present opportunity to prove that we will uphold our commitment to "Liberty and Justice for All", the year has presented many more opportunities for us as a committee and as an organization, to further our cause and to "Keep the Memory of our Ancestors Green". We hope that someone will remember the Veterans of the current War as we do those who protected our freedom over 140 years ago.

YEAR 2002-2003 SUCCESSES

During this past year many successes have been realized as a result of an active committee who were not afraid to continue the work that has been our purpose for several years. A sense of camaraderie and teamwork have continued to grow, as our members have left the comfort of their own Camps to guide the others in the effort.

Consecutive committee meetings were held in January, June, September and in December, and were attended by approximately 50% of the Camps. The issues that were addressed and resolved were:

- The Graves Officer's Handbook was upgraded and distributed to all Camps attending the Mid-Winter Conference. These updated sections of our "living document" now more closely reflect how the Committee really works.
- 2. The format and content of the Department database was reviewed, changed as recommended, and administrated. Discussions were held on extending our service to the community by putting the database on-line. Because of the diligence of the Committee, of Commander Butgereit, Department Webmaster Kirchberg, and Department Treasurer Williams that on-line database will become a reality by the time you read or hear these words.
- 3. Committee members expanded their effort to "spread the word" by attending genealogical society, historical society, or other appropriate venues in Berrien, Calhoun, Eaton, Jackson, Kalkaska, Kent, Livingston, Monroe, Washtenaw, and Wayne Counties, as well as at the National Encampment. This is a great way to make the public aware of out data and database, but we need more volunteers to attend, get some familiarity with the information, and then start working in their own areas. So far this year we have attended events at Plymouth and Monroe.

4. At committee meetings three special speakers presented on a variety of subjects.

- 5. Our contributions from the field stands at 38,659 records at the National and 42,374 at the Department level. The records reconciliation was completed this year, resulting in the removal of over 3000 records from the National.
- 6. Several administrative issues were addressed and resolved during the year. Two key ones were the confirmation of the contributions that Don Harvey, Ed Russell, and Camp 9 have made to the Program. Another was the successful retrieval of the Graves Records so diligently collected by Lynn Reaume on our behalf in Monroe County.
- 7. We now have 27 Counties that have completed the survey, research, and submittal of records. 5 more have completed surveys and are finishing the second phase. 39 Counties are actively being surveyed. If my math is right, that leaves only leaves 12 that aren't active.
- 8. As I reiterate, half of the Camps attended one or more meetings out of four. That is 14 different Camps that attended one meeting or more, 6 attended all four meetings... we have 12 Counties left to start.....12 Camps did not attend meetings......
- 9. At the recommendation and request of National JVC in Chief Stevens and National Graves Registration Officer Kennedy we assisted the new Department of Tennessee GRO by providing him with a copy of our Handbook, so that he could use it to structure his program.

Outside of the committee, the review and registration of existing lists of Michigan Soldiers buried at National Cemeteries continues. As the Committee decided, the burial place of any Michigan soldier will be documented in the Department record, as well as all Civil War Soldier buried in Michigan. We also record the resting places of veterans of all Wars Prior to World War I.

Queries are handled efficiently and professionally by the person to whom they are addressed, regardless of geography or position. In the future, as soon as all Camps assign a GRO, these requests for information will be routed to the Camp designee.

Several Camps have continued the verification of previously un-submitted registrations, and forwarding them to the Department GRO. Our hope is that with the new roster of Camp Commanders and GROs in Camps that previously did not participate, we can expand the program into all parts of the state. Spring is here, let's go!

An agenda of quarterly meetings was set for the year 2003.

FUTURE PLANS AND CHALLENGES

As we look forward, we see that the program and problems associated with program administration have taken a back seat to actually getting the job done. The Committee, has solicited resources outside the Membership so that only about 15% of the counties are not being surveyed. Hopefully, with the incentive shown by these people, the Camps that do not participate will join us.

Our plan and challenge for the next year, somewhat redundant to every year, is to get all records held by "completely surveyed" counties submitted, to complete the partially completed counties, and to encourage the appointment of GROs and participation by all Camps, so our new database is meaningful to all Camps.

We will actively work with the Department Webmaster in administrating the new on-line Department dB.

CONCLUSION

The Department of Michigan continues to be recognized as a national leader in Graves Registrations. With over 38,500 National registrations, the foreseeable trend would indicate that we will register many new graves every year for the next seven to ten years as our leaders and membership continue to drive the program. We have been asked to provide guidance to other Departments. We have enough Committee members that are willing to spend time on the Camp level to show a novice the ropes. Many of the experienced researchers come early and then attend our Committee meetings. The Graves Registration Program will continue to provide focus to an already great SUVCW agenda in the Department of Michigan... please support us as you can!





Historian's Report

Department Encampment Grand Rapids, Michigan

April 5, 2003

Historians in the Order are charged to collect and preserve historical and biographical material pertaining to the Civil War, to members of the Grand Army of the Republic, and to members of the Order. Accordingly, the Department Historian this year has solicited and collected materials of that kind. The items include a book from Brother John Mann, copies of veterans' military and pension records, photographs, newspaper clippings, magazine articles, printed programs, and Camp records. Most have been filed in four three-ring binders with archival protectors and indexes for ready reference.

Volume I contains copies of military and pension records of fourteen Civil War veterans. Some of the materials are complete files as obtained from the National Archives and Records Administration. Others are only the one or two pages submitted with SUVCW membership applications. This program provides a wonderful means for perpetuating the memory of the men who saved the Union. Brother Michael Nick suggested it and was the first contributor to it.

The second binder is a photograph album. One image shows officers of the Seventeenth Michigan Infantry at Grass Lake, Michigan, in 1865. Another was taken at the dedication of the monument to the Twenty-second Michigan Infantry at Chickamauga Battlefield. Among the veterans in the picture are the great grandfather and two great uncles of Herbert Marshall, of California, who furnished the photo. One of several sets of photographs has scenes of the dedication ceremony in Detroit of the International Memorial to the Underground Railroad. Other pictures portray events such as the installation of Camp officers and the dedication of monuments.

Volume III contains newspaper articles, printed programs and announcements, copies of "Michigan's Messenger," and agendas from Eagle Scout certificate presentations. Several newspaper items describe Memorial Day ceremonies held around the state. A funeral bulletin and a wedding announcement are displayed. Copies of the printed programs for the Department's 2002 Encampment and the Ceremony of Remembrance are exhibited.

The other notebook has published articles of interest. For example, some from the *Eaton County Quest* have copies of letters written by Union soldiers during 1861 and 1862. Among the stories from *Michigan History Magazine* are one entitled "Captured at Shiloh!" and another about "Return to Spotsylvlania." Also in Volume IV are copies of the records of Robert Finch Camp #14 for the years 2000, 2001, and 2002.

Preservation of the Department's records also received attention this year. The provision of fire-resistant storage facilities for them had been discussed at several

Department encampments but not pursued further. Brother Charles LaBar located some used fire-resistant file cabinets for sale last spring, and the Department Council authorized the purchase of one. However, the Marshall Historical Society subsequently declined permission for the Department to have any more storage space in their GAR hall. As a result, the purchase of a file cabinet was discontinued, and the search for suitable storage space was begun. That search still continues.

Sincere thanks to everyone who contributed to the History Collection 2003. The materials described above illustrate how each Camp and each member can contribute to the historical collection of the Department. Their participation in future endeavors of this office are greatly encouraged.

We have the honor to report continued progress by our Department's Camps, in support of the Civil War Memorials Assessment Project. With the increased participation, we have begun to enter the information from the assessment forms submitted by the Camps into our Department database. To date we have registered 85 monuments and memorials located within 24 counties across the State. Brothers have located and assessed the condition of 100% of monuments and memorials in Clinton, Eaton, Gratiot, Ionia, Jackson, Shiawassee, Washtenaw and Wayne Counties. Our thanks to the brothers of Camp's 1, 7, 14, 17, 58, 101,120, 160, 180, and 427 for their efforts and support of the project.

We would ask that newly elected Camp Commanders and Camp Civil War Memorials Officers contact this office with a report of their Camp's progress with the assessment of monuments in their assigned areas. We would also ask that the Past Camp Commander turn over all materials pertaining to the assessment project to the incoming officers. To those Camps who do not have a program in place we respectfully encourage them to appoint a Camp Civil War Memorials Officer to coordinate an effort within the Camp.

In April of 2001, after hearing the City of Detroit's plan to dismantle and relocate the Michigan Soldier's and Sailor's monument at Campus Martius, a message was sent by this committee to the city's planning director of our interest with this project.

After several communications over a one-year period, a meeting was set with representatives from the city's planning department and Mayor's office for May 29th, 2002. Information gathered from that meeting included an outlay of the plans for a park, which will be built at the center of Michigan and Woodward Avenues. The plans outline the Soldier's and Sailor's monument to be placed in a prominent location at the head of Woodward Ave. The monument will be set on a four-foot high stone pedestal with seating on all sides. In addition, a fountain will be constructed surrounding the base and will include a waterwall. The planting of trees, shrubs, and flowers around the monument and the mixture of blue stone pavers and crushed limestone paths will invite the public to view and appreciate the monument much more than in it's current location at the center of a traffic circle.

The monument will be disassembled this spring and stored before it is relocated to its new location. Construction of the remainder of the 1.6 acre park, that will include a central staging area for public events, a green space with benches and tables that will convert into a 7800 square foot skating rink in the winter months, is set for the summer of 2003 and will continue through the fall at this year. City Officials expect to have a dedication ceremony for the park in June of 2004, at which time consideration will be made for an appropriate rededication of the monument. This office was assured that it would be notified of any further developments or changes to the schedule of construction.

Another matter that was discussed with the city, was the replacement of the sign that was set at the corners of Woodward and Michigan Avenues in 1995. The marker,

Date: 04/05/2003 sponsored by the SUVCW, MOLLUS and the 24th Michigan Infantry Reenactors was placed there at the eastern end of US 12 to designate the highway as the "Iron Brigade Memorial Highway. The project, with the assistance of Brother Kent Armstrong, also included the placement of markers at the western end of US 12 at New Buffalo and another in Indiana. A proposal was given to place the Detroit marker adjacent to the monument after the park had been finished.

We are pleased to report the discovery of a significant artifact in the City of Petoskey. With the assistance of Brother Fred Knoodle, Camp 14 of Traverse City has acquired for restoration a cannon that has been stored at the city garage since its discovery in 1996. Through research by Brother Knoodle and some on sight inspection by artillery expert Wayne Stark, it was determined that the cannon was a rare 12-pdr Confederate Napoleon from the Augusta Foundry. The cannon is the only known iron cannon from the Augusta Foundry, which typically cast bronze artillery pieces for the Army of Tennessee.

Camp 14 has taken on the task of restoring the cannon for future display in Petoskey. They have gotten overwhelming interest and suggestions by many different sources. The Augusta Museum of History has contacted Camp 14 with its offer of advice and assistance in restoring the historical cannon.

Other restoration efforts underway by Camp's within the Department include the continued fundraising efforts of Camp 1 for the restoration of the memorial fountain in Grand Rapids. Camp Commander Butgereit reports the necessary funds may be obtained soon. Camp 14 with the assistance of Grand Traverse County, has continued to raise funds for the restoration of the white bronze monument on the County Courthouse grounds in Traverse City.

We are proud to report recent encouraging developments concerning legislation preventing the theft and sale of all veteran monuments, in particular the theft and sale of Civil War era cannon. House Bill No. 5888 was sponsored by and introduced by State Representative Larry Julian in May of 2002. Since then the bill has gathered the support of the American Legion of Michigan, The Commanders Group and the Department of Military and Veterans Affairs.

The bill would create a new act to provide for the disposition of demilitarized military equipment and artifacts, including Civil War era cannon. Specifically, the bill would require the recipient of such equipment from a federal agency to display the equipment in accordance with the agreement with the donor under the grant of conditional title. If the recipient no longer wished to keep the equipment or artifacts, he or she would have to return the equipment in accordance with federal law.

After consideration by the Veterans Affairs Committee, the bill has been recommended to undergo further language changes to set forth penalties and assign jurisdiction to a state agency. Once the language has been added, the bill will again be introduced and a new House number will be assigned.

After an updated House Bill number is introduced, we would respectfully encourage the members of the Department of Michigan to support this effort by contacting their elected state representative and ask for his or her support. Each camp will also need to step up their efforts with locating and assessing the condition of each Civil War era cannon and monument in their area. In doing so we can bring to the attention of local authorities and officials the importance of these pieces of their community's history and heritage. With your help we can prevent these collectors from profiting from what our ancestors and veterans of the Civil War entrusted to us to care for and ensure that future generations would not forget.

All four quarterly issues of Michigan's Messenger were published and mailed on or before the scheduled mailing dates. A combined total of 84 pages were printed for the year and over 550 copies were mailed to our members each quarter. Costs for the four issues were as follows:

According to our Department Treasurer, Richard Williams, from whom these figures were received, this represented 74% of the Department's total income for the year.

On 11 August 2002, at the 121st National Encampment in Springfield, Illinois, the Department of Michigan received the Marshall Hope Award for best Department newsletter. This award is based mostly upon interest and quality of content, along with consistency of publication. As editor of Michigan's Messenger, I had the honor of accepting the award on behalf of the Department from Commander-in-Chief George Powell. Though the award is presented to the Department of Michigan, it is our Department Officers, through their respective columns, our Camps, through their Camp News reports, and many of our Brothers, through their Ancestor Vignettes and other articles, that are the true recipients of this award.

On 20 March 2003, a request was received from the Genealogy Department of the Allen County, Indiana Public Library for a complete set of Michigan's Messenger newsletters and a subscription for future issues. The Allen County Library is the largest genealogy library in the mid-west and draws genealogists from all over the U.S. The letter stated, in part, "We believe a complete set of your publication would be of tremendous benefit to our patrons." The library has offered to pay all costs involved in obtaining the copies.

In preparation for the 2004 Andersonville Memorial Day services where we will rededicate the Michigan Monument upon its 100th anniversary, I put together a committee of representatives of from the SUVCW, WRC, DUVCW and Auxiliary. Our efforts will be the first of any state.

ARTICLE III - Officers and Their Duties

Section 2. The Commander, after his election, shall appoint other officers for a term of one (1) year as per the C&R. The appointed officers shall include, but not be limited to, the following: Chief of Staff, Patriotic Instructor, Chaplain, Counselor, Camp Organizer, Historian, Graves Registration Officer, Civil War Memorials Officer, G.A.R. Renumber Section 6 to 5. Reason: Section 5 was deleted.

Section 5. All officers (elected and appointed) shall upon their retirement from office, turn over to their successors, all property of the Department within ten (10) days after leaving office.

Add new Section 6. Reason: To insure that future generations will be given the opportunity to research who we are and what we did.

Section 6. Section 7. Pursuant to the C&R, a sufficient number of Brothers of the Department of Michigan shall be elected as Delegates and Alternates to attend and represent the Department of Michigan at the Annual National Encampment of the Order. Said election shall occur at the Annual Department Encampment preceding the National Encampment in guestion.

Delete Section 7. Reason for deletion: This same item is covered in ARTICLE XX – Annual Encampment, Section 5.

Section 4. The Secretary may be entitled to reimbursement of certain expenses necessary for the conduct of his office. Approval of reimbursement for expenses up to a maximum of one hundred dollars (\$100) per year shall be obtained from the Council. Typical expenses may include, but are not limited to, long distance telephone calls, postage, and mileage.

Section 5. The Treasurer may be entitled to reimbursement of certain expenses necessary for the conduct of his office. Approval of reimbursement for expenses up to a maximum of fifty dollars (\$50) per year shall be obtained from the Council. Typical expenses may include, but are not limited to, long distance telephone calls, postage, and mileage.

Delete Section 1-5. Reason for deletion: While this entire section was amended at the 2001 Department Encampment, it was never submitted to the Commander-in-Chief for approval. New Section 1 covers all officers affected.

Section 1. The Commander, Senior Vice-Commander, Junior Vice-Commander, Secretary, Treasurer (or Secretary/Treasurer) may be entitled to reimbursement of certain expenses necessary for the conduct of their offices. The amount of reimbursement shall be approved by the Council in their review of the budget proposed by the Treasurer. Typical expenses may include, but are not limited to, long distance telephone calls, postage and mileage.

ARTICLE VII - Reports

Section 2. The Secretary shall make and keep a record of the proceedings of the Annual Encampment. He shall make a regular report of the correspondence received and sent, and other activities as required by his office, to the Commander as often as required by the C&R. Section 1. The Standing Committees shall be as follows: Bylaws, Legislative, Membership, Graves Registration, *Memorials and Monuments*, G.A.R. Records, Communications and Technology, and Nominating.

Section 4. The Bylaws Committee shall be chaired by the Senior Vice- Commander and shall annually review these Bylaws, bringing any necessary revisions to the attention of the Department membership.

Revise Section 4. Reason for revision: This additional wording helps insure that the Department Senior Vice-Commander will forward the revised By-laws to the Department Signals Officer for posting on the Department website.

Section 4. The Committee shall bring to the attention of the Department any disrespect or lack of attention shown to any Civil War monument or memorial. The Committee shall be chaired by the Civil War Memorials Officer.

Renumber Section 12 to 11. Reason: Section 11 was deleted.

Section 12. The Ceremonies and Rituals Committee shall assist Camps with appropriate use of the Ritual in performing ceremonies at Camp functions. It shall help Camps to organize Camp Guards and provide training for these groups in effective presentations and programs. Revise Section 2. Reason for revision: With our new Annual reporting method and the April 30 deadline for Camps to submit their reports to the Department Secretary, the time period used (currently March to March) to determine Camp growth awards must change. We recommend that in order to be considered for either of the two awards available, a Camp must submit a current roster, showing increases and decreases over the past 12-months to the Department Secretary no later than February 15. The time frame used would be from February to February.

Section 2. Authorization for two (2) Department membership awards is provided. The Department may confer an award upon the Camp within the Department of Michigan that initiates the most new Brothers from February 1 to February . This award shall be designated as the Governor Austin Blair Membership Award. The Department may also confer an award upon the Camp within the Department of Michigan that demonstrated the largest percentage growth from February 1 to February . This award shall be designated as the Orlando LaValley Membership Award.

Camps must submit a current roster, showing increases and decreases in membership to the Department Secretary no later than February 15 of each year. The awards will be distributed at the Annual Department Encampment.

ARTICLE XX - Annual Encampment

Section 1. All delegates to the Annual Department of Michigan Encampment, including Past Department Commanders, current and Past Camp Commanders, Department Officers, and Camp Delegates, or Camp Alternates serving in the absence of the Camp Delegates, shall be charged a *Registration Fee*. The kepi may be decorated with any of the following: a hat badge consisting of an open top wreath encircling the letters "SUV" of gold color, affixed to the front center of the kepi, a Department of Michigan Cap Mark of the Civil War Union Army VII Corp Style, consisting of a crescent moon over a five point star, affixed to the top center of the kepi. The VII Corp Camp Mark shall be red with optional gold edging and silver star. The jacket shall be civilian blazer or a Civil War-period Union Army four button fatigue blouse (also known as a sack coat), dark blue in color, with (optional) affixed to the right collar the letters "MICH" and affixed to the left collar the letters "NO." followed by the member's Camp number, ½" in height, all of gold color. Dress style slacks of dark blue or black color, a dress style shirt, solid white in color, a necktie of subdued color or

Bruce Butgereit handed out black ribbons that can be worn behind the membership badge when the charter is draped in black. Bruce paid for the 1000 ribbons and asked each participant to pick one up and asked that Camp Commanders pick up ribbons for camp members not present at the encampment.

Old Business:

Bill McAfee, Department Chaplain, asked that the death notice be used by the camps to notify him of any deaths so he can pass the information on to the National Chaplain so a card can be sent to the surviving family members on behalf of the Department.

Jim Lyons asked how can we know what old business should come before the encampment when the minutes from last years Encampment haven't been distributed? Some participants received the 2002 Encampment minutes, but most have not received them.

Council:

Report from the council was given by Keith Harrison. Keith recommends the Camp-at-Large membership dues be increased from \$25 to \$26 to cover the needed minimum due to pay per-capita. James Lyons moved the recommendation be accepted by the encampment. Seconded by Rick Danes. The motion passed.

Officer Reports:

The Committee on Officer Reports was presented by Dave Wallace. The committee recommends the adoption of the minutes of the 113th annual encampment with the following corrections.

1) Page 4, PC-in-C Harrison reported that the GAR flag is missing from the display of veterans organization flags in the State Capitol. He indicated that the VFW Department of Michigan will assist by raising funds to help replace it.

2) Page 5, correct the spelling of Camp 20's secretary from Borker to Baker.

Bill McAFee move the minutes be accepted as corrected. Seconded by Gary Gibson. During the discussion James Lyons objected that the minutes of last years encampment not be approved until the member of last years encampment have had a chance to review the minutes. Keith Harrison suggested the minutes be tabled until next years encampment and that the minutes from the 2002 Department Encampment be distributed to the attendees of the 2002 Department Encampment for their review. Motion made by Rick Danes to table the 2002 Department Encampment minutes until next years encampment. Seconded by Neal Breaugh. Motion passed.

By-laws:

By-laws Committee Report was given by Keith Harrison. See attached by-law changes.

We got into a discussion on the Department Encampment's inability to make any changes to any wording of the by-law changes at the Department Encampment because of the 60 day limit imposed in the by-laws and a ruling by the National Counselor at last year's Department Encampment. A lengthy discussion followed as to whether the change was at all necessary. We determined the change was necessary.

- Article XIV, Amendments, Section 2. This proposal allows the encampment to modify wording in the previously distributed by-law changes. The encampment by-laws committee recommends the proposal be accepted. A discussion followed. In the end, the by-law change was determined necessary. Neal Breaugh moved the by-law change be adopted. Seconded by Robert Graves. Motion passed. The Commander-in-Chief, Bob Grim, was asked if he'd approve that change to the Department's by-laws immediately. He did.
- Article III, Officers and their duties, Section 2. Change the Civil War Memorials Officer title to match the title changed at the 2002 National Encampment. We've subsequently learned that the title change should not have been made at national level and the committee recommended the change be rejected. Motion made by James Lyons to reject the proposed change, seconded by Robert Graves, Motion passed.
- Article III, Section 5. By-laws committee asked this section be removed because a committee of the Michigan Allied orders handles the selection of the site. The encampment by-laws committee gave no recommendation. A discussion followed indicating it was still the responsibility of the Department of Michigan SUVCW to determine where the next encampment site will be and should not be relinquished to a committee although a committee of the Allied Orders in Michigan can still be formed under the current provisions. James Lyons moved the change be rejected. Seconded by Howard Streeter. Motion passed.
- 4) Article III, Section 6. By-laws committee asked the section be renumbered to section 5 because of its recommendation to eliminate section 5. Removal of section 5 did not pass. Bill McAfee moved and Dave Wallace seconded that the change be rejected. Motion passed.
- Article III, add new Section 6. This new section would require Department Officers to turn over all materials when relieved of duty to the Department Historian. The encampment by-laws committee gave no recommendation. Rick Danes supported the addition and Richard Veit supported. A discussion followed bringing up many good points on preserving the materials, cost of copying, reimbursement, storage, and access to the data. Jim Lyons moved and Gary Gibson seconded to table the proposal until next year encampment. The proposal is to be sent to the By-laws Committee to set up procedures for implementation of the proposal and report to the next Department Encampment.

Article III, Section 7. Delete the election of delegates to the National Encampment since it is covered in Article XX. The encampment by-laws committee recommended to accept. A discussion pointed out the section is not redundant with Article XX. Dave Wallace moved and Gary Gibson seconded that the section not be deleted. Motion passed.

- Article IV, Authorized expenditures. The proposal is to delete Sections 1-5 and replace it with a general statement that officers will be reimbursed for expenditures approved by the council after review of the budget proposed by the Treasurer. Jim Lyons moved and Dave Wallace seconded to support the change. Motion passed.
- Article VII, Reports, Section 2. Put a timetable on getting the encampment minutes to Department Officers 60 days after the encampment. Jim Lyons proposed an amendment to also include Camp Commanders, Camp Secretaries and all attendees of the Department Encampment. Gary Gibson moved and Richard Veit seconded that the amendment be accepted. Motion passed. Dave Wallace moved and Gary Gibson seconded the amended proposal be accepted. Motion passed.
- 9) Article IX, Committees, Section 1. The proposal was to change the Civil War Memorials committee to Memorial and Monuments. An earlier change negates the necessity to do this. A discussion followed and it was determined since we can modify by-law changes at the encampment that we would modify this proposal to take out the Weekend of Remembrance Committee and add the Ceremonies and Rituals Committee. Neal Breaugh moved and Rick Green seconded the modified proposal be accepted. Motion passed.
- 10) Article IX, Committees, Section 4. Modified to send modified by-laws approved by the Commander-in-Chief to the Department Signals Officer to post on the Department Website. Dave Wallace made an amendment to the proposal to also include that the proposal comply with the National Organizations' Electronic and Communication Policy for storage on the website and that Camp Commanders and Camp Secretaries also receive a copy of the approved by-laws. The amendment was seconded by Jim Lyons. The amended proposal passed.
- 11) Article IX, Committees, Section 8. Change the name of the committee from Civil War Memorials to Memorials and Monument. An earlier motion rejected the name change. The encampment by-laws committee recommended to reject the change. Bill McAfee moved and Rick Danes seconded that the change be rejected. Motion passed.
- 12) Article IX, Committees, Section 11. Delete the reference to the Weekend of Remembrance Committee since it no longer exists. The encampment by-laws committee recommended to accept the proposal. Moved by Dave Wallace and seconded by Jim Lyons to accept the proposal. Motion passed.
- 13) Article IX, Committees, Section 12. Renumber to 11. The encampment by-laws committee recommended to accept the proposal. Moved by Dave Wallace and seconded by Jim Lyons to accept the proposal. Motion passed.
- 14) Article X, Camps, Section 5. Addition to have Camps turn over to the Department Historian copies of history of the Camp each year. The encampment by-laws committee recommends this proposal also be tabled until next years Department encampment. Dave Wallace moved and Jim Lyons seconded that the proposal be tabled until next years Department Encampment. Motion passed.
- Article XVI, Awards and Insignia. This proposal changed the time period to determine the membership awards normally presented at the encampment. Jim Lyons suggested the new reporting method will allow the Department Secretary to keep up with the changes on a monthly basis and thus be able to determine the recipients of the awards before the Department Encampment. Jim Lyons moved and Dave Wallace seconded that the proposal be rejected. Motion passed.
- 16) Article XX, Annual Encampment. Add a new section to change the period of time for determining the Camp delegates to the Department Encampment. Jim Lyons moved and George Roux seconded that the proposal not be accepted. Motion passed.

(Additional by-law changes after the Department Operating Guideline changes.)

Article III, Section 20. Add as the last sentence, "All delegates and alternates shall be brothers of the Department of Michigan." The change was moved by Jim Lyons and seconded by Gary Gibson. Motion passed.

Keith Harrison, Council Chair, moved that the Treasurer's budget as presented to the council and discussed earlier in the encampment, be approved. Seconded by Howard Streeter, Council member. Motion passed.

Committee Reports:

Gary Gibson reported no recommendations were in any officer report. Found the reports in good order. Jim Lyons move the Committee Report be adopted, seconded by Dave Wallace. Motion passed.

Jim Lyons objected not having a chance to review the minutes from last year and will move to take the minutes off the table. Dave Wallace seconded. Motion passed. (Under Officer Reports, the 2002 Department Encampment minutes were tabled until next year. This motion remove that motion.)

Jim Lyons moved the minutes for the 2002 Encampment be approved as amended earlier in the Encampment. Seconded by John McFeters. Motion passed.

Election of Delegates to the National Encampment:

Keith Harrison moved that the delegates to the National Encampment be determined by reverse alphabetical order of the registered delegates at the Department Encampment less any members with outstanding credentials to the National Encampment up to our maximum number of delegates allowed and all others on the Encampment list be alternate delegates. Seconded by Jim Lyons. Motion passed.

Nominating Committee Report:

Bruce Butgereit II read the names for the elected officers of the Department. No nominations were made from the floor. Jim Lyons moved the nominations be closed and the Secretary be moved to cast a unanimous ballot for the slate presented. Seconded by the encampment. Motion passed.

For the Good of the Order:

Gary Gibson moved the encampment donate \$25 to the Sr Vice Commander-in-Chief's fund and \$25 for the National Patriotic Instructor's Fund. Seconded by Rick Danes. Motion passed. (Motion passed earlier.)

Jim Lyons moved that the minutes of these proceeding as they are transcribed, distributed and presented to the next encampment and upon approval at the next encampment become the official record of this encampment. Seconded by Dave Wallace. Motion passed.

Camp 7 on April 14 will have their 89th anniversary. They will have treats and all are welcome.

June 14 at the State Museum will be celebrating flag day. Bruce Butgereit asked for a show of hands on who might want to attend.
