CREDENTIALS COMMITTEE PRELIMINARY REPORT – Dean Lamphere reported 60 brothers present and entitled to vote.

OFFICER'S REPORTS CONTINUED:

GAR Records Officer – Gary Gibson

Civil War Monuments Officer – Dennis Fyke

DEPARTMENT COUNCIL: Report of the Department Council was then presented by Chuck Worley.

- 1. Council approved funds to Michigan's GAR Museum, the repository of our Department Records, to assist the Museum in digitizing Department Records.
- 2. Council approved funds to purchase a Michigan Department GAR flag to be presented to the State of Michigan.
- 3. The Council reviewed the records of the Department Treasurer and found them to be in order.

COMMITTEE REPORTS:

102nd COLORED TROOPS MONUTMENT COMMITTEE. Bob May reported on the Committee to place a memorial to the 102nd Colored Troops near the State Capital. Approval from State of Michigan being sought to place monument at this time. State officials and Representatives are supporting this effort. A monument company has been located to actually make the monument. The costs will be in the \$16,000.00 to \$20,000.00 range. Fund raising efforts are underway, including photo mats and pledge cards. The target date of September 30, 2017 to dedicate the monument has been set, as this is the anniversary date of the muster out date of the 102nd USCT (and also a Saturday). Crapo Camp is holding funds at this time raised from the sale of photo mats. A grant application will also be made to the National Organization. Extra funds from sales of photo mats will go to other monument projects. Right now, only pledges are being sought, but once the approval is given by the State of Michigan, those pledging will be contacted to actually make the donations.

Monument will be 3'x3'x5'. On front will be "102nd USCT", on the rear will be "Placed by Sons of Union Veterans of the Civil War". On one side will be description of the regiment and the other side will have a listing of all battles and engagements the regiment was engaged in.

Motion made and seconded to consider recommendations of Committees at the sound of the gavel unless objection is voiced – motion carried.

Recommendation by Committee to appoint committee another year approved.

Recommendation by Committee the Department to pledge \$500.00 towards the monument project – after much discussion and questions, the recommendation was amended by motion and second to change the amount to \$1,000.00. Motion to amend did not pass. Motion to pledge \$500.00 – motion carried.

BYLAWS COMMITTEE – two changes submitted:

Add section 4 to article 18 – Dr. Mary Edwards Walker Award – Motion carried.

ARTICLE XVIII

Awards and Insignia

Section 4. Authorization for a Department Doctor Mary Edwards Walker Appreciation Award is provided. The Department Commander may confer the award which is presented to Sisters of the Allied Orders in recognition of outstanding, sustained and conspicuous service to the Department of Michigan of the SUVCW in furtherance of its mission and goals. The medal and certificate would be presented to a recipient with a red ribbon to denote it was presented by a Department. The Department Commander may present up to 3 awards per administration upon recommendation of any Past Commander-in-Chief, Past Department Commander or current Camp, Department or National elected officer.

Add section 5 under Article 22 – Proceedings. Creates a Department Proceedings modeled on the National and appoint an Assistant Department Secretary-Proceedings Editor. After some discussion – Motion carried.

Article XXII

Proceedings

Section 5. The Department Commander may appoint an Assistant Department Secretary - Proceedings, to help the Department Secretary compile the official record of each Department Encampment. The Department Proceedings shall include the minutes of the business meeting, each officer's report and other such items so as to make a complete record of the Encampment. The proceedings of each Encampment, when approved by the outgoing and incoming Department Commander, when published, become the official record of that Encampment. The official record of that Encampment shall be published to the Brothers of the Department in an electronic format.

CEREMONIES AND RITUALS COMMITTEE – no recommendations

2017 NATIONAL ENCAMPMENT COMMITTEE – 2017 National Encampment will be in Lansing, Michigan in August of 2017. Committees are formed and fund raising efforts are underway. The Department has set aside some \$19,000.00 for this purpose.

Recommendation – Committee continue with current membership. Motion carried.

Recommendation - Encampment in the coming year to allow the Committee to begin spending up to \$10,000.00 from Department funds set aside for this purpose and the Department Treasurer begin paying the bills associated with hosting this Encampment. National Chief of Staff Michael A. Paquette addressed the Encampment concerning things about hosting a National Encampment. Motion carried.

ENCAMPMENT RESOLUTIONS COMMITTEE – none presented and Encampment Committee discharged.

ENCAMPMENT OFFICERS REPORTS COMMITTEE

Department Commander recommended an editorial page in the Michigan Messenger, referred to Editor of Messenger for consideration – carried.

SVDC recommended review and updates to bylaws as to Art 9, sec 12 and Art 22, Sec 1, referred to Department Bylaws Committee to report back to next Encampment. Other recommendation modification as to memorial services, referred to incoming Dept Commander.

Treasurer recommended income from permanent fund be channeled into principal. Carried. Second recommendation was funds designated for the observances of the Civil War Sesquicentennial are returned to the General Fund. Carried.

Secretary recommended Art 18, Sec 2 be reviewed as to membership awards. Referred to bylaws committee for review and report back next year.

JVDC had 4 recommendations

- a. Memorial national memberships for additional ancestors with onetime payment. Referred to bylaws committee for study.
- b. Use single membership application form 3. Referred to National Committee on Program and Policy.
- c. Contact all Dept JVDC across the Order to learn what is successful and not successful in recruitment and retention. Referred to the National Committee on Membership, which is chaired by the Junior Vice-Commander-in-Chief and the membership of that committee is all Department Junior Vice Commanders.
- d. Update new member recruitment and retention form. Referred to incoming SVDC and Bylaws committee.

OLD BUSINESS – none presented.

NEW BUSINESS -

SVDC moved the Department recommend to the National Organization, the Dr. Mary Edward Walker award be amended to include the Daughters of the Union, (a separate organization and not an Allied Order). After discussion, motion failed.

GOOD OF THE ORDER

Encampment Committees were discharged with thanks of the Department Commander, except the Nominating Committee.

Motion to endorse brother Don Shaw for the office of Junior Vice Commander-in-Chief at the 2016 National Encampment and send endorsement to the National Organization. Motion carried.

Motion to endorse brother Paul Davis for the office of National Council member at the 2016 National Encampment and send endorsement to the National Organization. Motion carried.

National Encampment is August 11 to 14 in Springfield, IL and the Department Commander encouraged a full delegation.

Remembrance Day in November in Gettysburg, Pennsylvania

July 9, 2016 is the delivery of the G.A.R. Department Flag to the State of Michigan as part of the 150th Anniversary of the Return of the Michigan Battle flags.

Motion was made to make a donation to Great Lakes Christian College in thanks for allowing the use of their facility in the amount of \$100.00. Motion to amend to \$200.00. Motion to amend carried. Motion as amended was not voted upon.

AWARDS

Abraham Lincoln Award: Robert May of Camp 145, Dick Williams of Camp 58 and Ed Houghtaling (non-member) for Graves Registration work.

Austin Blair Award - for the greatest gain (numerical) - Robert Finch Camp 14

Orlando LeValley Award - for the greatest percentage gain – Henry Wallace Camp 160

Certificates of Appreciation were given to Jan Northrup, Ann Davis and Jean Rose. These people were nominated for the Abraham Lincoln Award. Jan and Ann are members of the Daughters of the Revolution who are working with Camp 135 in graves registration work. Also a Certificate of Appreciation was given to Keith Harrison.

Certificates were provided to the Department elected and appointed officers.

BUDGET

The Department Treasurer made a presentation concerning the 2016-2017 budget. At the beginning of the Encampment, there were budgeted revenues of \$6,100.00 and expenses of \$5,980.00 with surplus of \$210.00. Then the Encampment pledged \$500 to the 102^{nd} fund, creating a deficit budget of \$-290.00. Motion to approve the budget, seconded and carried.

As there were two qualified candidates for Department Junior Vice Commander, it was recommended each be given five minutes to address the Encampment.

Motion that if at the close of nominations for any particular office, if there is only one candidate, the secretary cast a unanimous ballot and declares that person elected. Motion carried.

NOMINATIONS FROM THE FLOOR

Nominations were called for from the floor. For each nominee, they were asked if they were willing to serve and if they held any other elected office in the Order. After nominations from the floor for each position was announced, nominations were closed.

Commander – no other nominations received, Dean Lamphere stands elected.

Senior Vice Commander – no other nominations received, David Smith stands elected.

Junior Vice Commander – no other nominations received, but with two nominees from the Nominating Committee, each was allowed five minutes to address the Encampment.

Secretary – no other nominations received, Gerald Jacobs stands elected.

Report of the Department Treasurer

Commander Aurand, Officers and Brothers of the Department of Michigan

The Department of Michigan has concluded the financial business of the Membership Year and our finances continue to be positive. We posted rever and expenditures during 2015 of \$5,854.60 and \$1,189.78 respectively to General Fund. This resulted in an excess of revenues of \$4,664.82 for the y Total funds available amounted to \$20,187.31 as of December 31, 2015. Of total, \$757.50 is the Sesquicentennial restricted account, \$86.60 is restricted Gettysburg flag replacement and \$182.50 remains in the Greenville Monun restricted account. A total of \$19,160.71 represents unassigned cash that ma disposed of by this Encampment.

Additionally, the Department of Michigan Permanent Fund reflects a tota \$38,908.38, which consists of a permanently restricted balance of \$37,849.02 at temporarily restricted income accumulation of \$1,059.36.

I wish to report:

- 1. All permanent fund assets have been invested in government-bac securities through an Edward Jones account. Interest rates on investm are between 2.5% and 3.875% with a net yield of 2.80% on our investm for the year.
- 2. That actual expenses incurred for the year were \$4,160.22 under budgeted amount for the year.

I offer these recommendations for consideration by the Encampment for coming year:

- 1. That the \$1,059.36 in income generated by the Permanent Fund in 201 retained as part of the permanently restricted balance of the fund.
- 2. In that the Sesquicentennial has ended, that the remaining restribalance of \$757.50 designated for the observance of the Sesquicenten be transferred to the restricted balance of the Permanent Fund.

3. That the proposed 2016 operating budget for the General Fund, attached to this report, be accepted as presented.

I appreciate the trust placed in me by the Brothers of this Department in electing me to the position of Treasurer for this past term of office. I have submitted my name for consideration by the Encampment as Department Treasurer in the coming year. It has been an honor to serve the Department, and continue to be proud to be able to offer my professional skills in this position.

On those occasions when advice has been sought, I did my best to offer what I considered to be sound advice based on my understanding of the realities within the Department and in light of our Department By-Laws and the current National C & R.

I was able to assist the Commander as an installing officer for officer installation of one of the camps. I thank those with whom I have worked for a most satisfying experience and look forward to serving in whatever capacity I can in the future. I have no recommendations for this encampment.

DEPARTMENT COUNCIL

Robert Griggs, Kevin Lindsey, Charles Worley

Commander, Brothers, and Distinguished Guests of the Order; The brothers of the Department Council are pleased to offer our report to today's Encampment. The 131st Encampment delegated two items to our care. The first item, we approved the transfer of \$200.00 from the GAR Documents Fund for the immediate use of the GAR Memorial Hall and Museum to digitize documents that are in the Museum possession.

The second item, the Council approved the use of funds to purchase a GAR Flag to present and place in the State Capital in Lansing. The GAR Flag is in commemoration of the 150th anniversary of the founding of the Grand Army of the Republic. In order to maintain uniformity with the other Service Flags, there was a \$20.00 increase above the original quote. The council approved the request.

Worthy of note, the Council reviewed the Department Treasurer's financial sheets on a quarterly basis. We found our revenues and expenditures to be usual and customary for our Order. The Department Permanent Fund continues to earn interest from our bond instruments.

GRAVES REGISTRATION OFFICER

Richard E. Danes

This will serve as the final report for the year 2015-2016 of the activities of the Department Graves Registration Committee.

Reiterating my report from past years, the achievements of the Committee, although significant, did not meet the stated goals of previous years Committee Reports - we were not able to recover all graves related records from all camps, and although we encouraged all camps to appoint an active Graves Registration Officer (CGRO), some camps still fail to do so. I will be happy to share the Camps that do not participate at a later time.

The Committee met quarterly, realizing our 6dh meeting in March of this year, as we achieved an average attendance of 50% of the total camps in the Department at each meeting these meetings created meaningful dialog that is useful to Camp Graves Registration Officers and allowed them a forum to express ideas, concerns, and to spend time teaming about the resources available to them.

We use a handbook developed by the committee that standardizes abbreviations, sources, and report content. Each CGRO that attends a quarterly meeting receives an updated copy of the complete department database which is used in their research and in sharing information with the public. Every quarter the updated information is put on-line by our Department Signals Officer. That database has reached 68,300 records of hero's buried in Michigan and outstate location.

Under the Department Commanders leadership, the Department of Michigan Graves Registration Program continues to flourish, and remains a program second to none in the National Organization.

GAR RECORDS OFFICER Gary L. Gibson, PDC

It has been a pleasure to serve in this office this year. I received several inquiries from individuals across the country searching for information on their Michigan Civil War ancestor. It is rewarding to be able to assist them. The work of the GAR Records Officer and committee continues. Even though progress is being made, I constantly have to remind myself that this is not a sprint, it is a marathon.

First of all, there have been no expenses incurred by this office this year.

The work of this office has been to not only locate the records of the several posts of the Department of Michigan, GAR, but to assist in their preservation in any way possible. Leads as to the possible locations of GAR records can come from several sources: libraries, archives, individual knowledge, and from old newspapers.

Incorporated into the mission of the GAR Records Committee has also been to seek out information on the meeting places of the posts of the Grand Army. Many posts in Michigan built their own buildings, while others met in halls occupied by the Masonic Orders, or even the Odd Fellows. My predecessor, Brother Jim Lyons, always said that you can learn quite a lot about a post by their meeting place. One of the avenues of preserving the records of the GAR in Michigan has been to collect photographs of Michigan GAR halls, including both those that are still standing, and those that no longer survive. It is my hope that when possible, the GAR Records page on the Department website can be updated, and we will add photographs of the several post halls that have been collected. To date, 15 halls are known to still stand in Michigan.

Brother Tom Bruce of Gen. Benjamin Pritchard Camp No. 20 of Kalamazoo, in his capacity of Graves Registration Officer, has also been on the lookout for surviving GAR Halls and meeting places, and he has been successful in Van Buren County. He located the meeting places of the Edwin Cowell Post No. 23 of Bloomingdale, which met in a brick building at 102 East Spring Street. This building is currently being used by the local Masonic lodge. Colvin Post No. 59 of Gobles met in several places, and the last was the Post Commander's home, which still stands at 202 North State Street.

Bro. John Keith, Commander of Camp 20, was able to locate old photographs of the building that the Willard G. Eaton Post No. 34 of Otsego in Allegan County met in. That building was used as a hotel on the stage lines in the 1800's. Unfortunately, it no longer stands. Copies of these photos are now in our files.

During this fiscal year, this office, and as it turns out, several others, were contacted by the United States Postal Service. Four documents, including two pertaining to Ruddock Post No. 224 of Cheboygan, and two pertaining to the Civil War Centennial of 1961 – 1965, were found undeliverable by the postal service. Their inquiry solicited possible options for delivery. This office suggested that as Post 224 had closed many years ago, and the Sons of Union Veterans were the legal heir and official representative of the GAR, that placement of these documents in our archives would be desirable. As of this writing, repeated inquiries to the US Postal Service as to the disposition of these documents have gone unanswered. Fortunately, scans of these documents had been forwarded to this office and are now part of the records of the Department of Michigan. (On a personal note, my great-great grandfather was a charter member of Ruddock Post No. 224.)

The records of this office are housed at the James B. Brainerd Post No. 111, GAR Memorial Hall and Museum in Eaton Rapids. A recent cursory check of these records has found them to be in excellent condition, owing to the wonderful care by the excellent staff of this outstanding museum.
